ELECTION NOTICE

It is hereby notified that a General Election of Members of the West Bengal Pharmacy Council under clause (a) of Section 19 of the Pharmacy Act, 1948 as amended from time to time, will shortly be held and that for this purpose the Returning Officer has under rule 2(1) of the Election Rules made by the Government (published with Government Notification No. Medl/4726/3P-16/66 dated 21st July, 1966 in the Calcutta Gazette Extra-Ordinary of July 22, 1966) appointed on 25.08.2022 as the date up to which the names and other requisite particulars of the persons entitled to vote at the election have been entered on the Draft Electoral Roll.

The Draft Electoral Roll would be kept open for public inspection under rule 2(3) of the Election Rules in the office of the Returning Officer at Purta Bhawan, Ground Floor, Room No. 5 & 6, Salt Lake, Sector-I, Kolkata-700091 from 15.09.2022 to 29.09.2022.

Any claim for inclusion of a new name, if registered & still borne within the appointed date i.e. 25.08.2022 but not appearing in the Draft Electoral Roll, or any objection to any entry in the Draft Electoral Roll, shall be made in the form prescribed in the Election Rules, namely Form A or Form B as the case may be (copies of which will be provided on application from the office of the Returning Officer and will also available in the official website of West Bengal Pharmacy Council i.e. www.wbspc.in. Such claim or objection shall be filed within the said period i.e., from 15.09.2022 to 29.09.2022 and will be examined and decided by the Returning Officer and his decision will be final under rule 2(3) of the Election Rules.

The Draft Electoral Roll will be corrected in accordance with the decision of the Returning Officer and the roll thus corrected shall be the Final Electoral Roll for the election. In the preparation of the Final Electoral Roll, registration and restoration after the afore-mentioned appointed date, i.e. 25.08.2022, or new qualifications or employment obtained after that date will be disregarded and no person whose name is not included in the Final Electoral Roll for election, shall be entitled to participate in the election. Changes of address after the Final Electoral Roll has been prepared will be disregarded. [Rule 2(4) of the Election Rules].
